#### ITEM #1 APPROVE MARCH 20, 2014 REGULAR MEETING MINUTES

#### ITEM #2 APPROVE APRIL 4, 2014 SPECIAL MEETING MINUTES

President Holmes presented the minutes of the April 4, 2014 Special Meeting to the Commission. FM Dodge requested a minor clarification stating that the final GM candidates had been interviewed by the board earlier in the day during the Tri-Dam Project special meeting. Commissioner Clark moved to approve the minutes with the

noted clarification. Commissioner Holbrook seconded the motion. The motion passed unanimously.

## ITEM #3 PRESENTATION BY RICHARDSON & CO., 2013 AUDITED FINANCIALS

Brian Nash from Richardson & Co. presented Tri-Dam Power Authority's 2013 audited financial statements, noting that his firm has issued a clean opinion. Mr. Nash also discussed the drought footnote added to this year's financial statements, and the implementation of GASB 65 requiring that capitalized bond offering expenses be written off in the current period. The implementation of GASB 65 necessitated a relatively minor restatement of the 2012 financial statements.

Commissioner Holbrook moved to accept the 2013 Audited Financials as presented. Commissioner Bairos seconded the motion. The motion passed unanimously.

Finance Manager Dodge reviewed the Financial Statements with the Commissioners.

## b) Review and Approve Statement of Obligations

Finance Manager Dodge reviewed the Cash Flow Report with the Commissioners.
